### INTRODUCTION

Since its foundation, FAPMI has developed and implemented more than 170 programs and projects about prevention, detection, notification, attention and intervention regarding child protection, child maltreatment and the promotion of the good treatment and child well-being. These activities are implemented with the support of collaborators, wide networks, including national, regional and local Governments, Administrations and Organizations (as NGOs or Foundations) regarding child protection or prevention of child mistreatment.

In this Summary we present a brief revision of the Programs of the Federation. More information can be found in the Annual Activities Reports or in other documents. A list of them is included at the end of the description of every Program. In this Summary we have preferred not to include information about the Regional Programs developed by the Member Associations of the Federation, provided that its description would turn out to be very long. In any case, the information mentioned above is available to the interested parties.


Regarding main strategies used by FAPMI implemented to fulfill our mission and vision, we consider these as the most important aspects:

- PREVENTION AND AWARENESS: Prevention campaigns and actions oriented to general
  population and professionals directly and indirectly related with the attention to child and
  adolescents from different fields.
- DIFFUSION OF INFORMATION: Diffusion of information related to prevention, detection, notification, attention and intervention in cases of child mistreatment and Protocols of Action.
- **3. QUALIFICATION:** Training of professionals of different fields (education, health, social services, police, monitors of leisure...).
- 4. KNOWLEDGE MANAGEMENT: Elaboration of reports and research projects regarding detection of and attention to children and adolescents victims or those at risk. Management and diffusion of scientific information, validated programs and best practices by means of the Virtual Documentary Center in collaboration with the University of Salamanca.



- 5. ADVOCACY: Participation in the process of elaboration, follow-up and evaluation of regional and national policies and Plans. From our experience and knowledge in the field of child protection and attention to cases of child and adolescent mistreatment, the Federation tries to move them to the decision-makers and people and structures with power to improve the attention to children, adolescents and families at different levels.
- **6. CONSTRUCTION AND PROMOTION OF NETWORK:** Promotion of networks and collaboration with other organizations, administrations, professionals and individuals which have similar or complementary aims with the Federation. The most relevant events regarding this are:
  - Participation in the foundation of the National Platform of Child Organizations and participation in its Directive Board.
  - Participation in the constitution of the Consortium ECPAT España since its foundation.
  - The member Associations of FAPMI participate in the regional networks regarding child protection.
  - Since its foundation, the Federation and its Associations are actives collaborators with numerous Organizations, Administrations, Governments and individuals to obtain its goals.

All of these main strategies are included in the FAPMI's II Strategic Plan (2011-2013) and all the Programs of the Federation are related with one or more of these main strategies. In the following graph we present an overview of the areas of work of the Federation and its relation with Associations.








### **PROGRAMS OVERVIEW**

### SP1: "JUSTICE AND CHILDHOOD"



### **SUMMARY**

The subtitle of this Program is "Recommendations and Good Practices to improve the attention to Children and Adolescents in the juridical field". In this section we summarize our intentions and the aims of the Program. Spain has advanced a lot in the last few years regarding this issue, but we need to continue working with the objective to guarantee that children and adolescents will not be victimized for a second time when they are in the necessity to participate in the judicial system and in the juridical process.

### **OBJECTIVES**

The Justice and Child Program presents the following general objectives:

- Improve the attention to children and teenagers that see themselves in the obligation of participating in processes of juridical character and especially those of judicial character through the promotion of Good Practices and applicable recommendations by professionals and institutions in the field.
- Provide information of both legal and psychosocial character to the professionals that surround children and adolescents in the judicial process, in a way that they can give them the best possible care and prevent mistreatment caused by the very own dynamic of the institution.
- Guide our actions to all agents involved in the process, with special attention to those that are minors of age and their families.
- Influence in a special way, those responsible of decision making in matters related to the care of children and adolescents in the field of Judicial Administration.
- Conduct regular monitoring of the changes related with the participation of children
  and teenagers in the judicial field and its processes; actively involve all significant
  players in its elaboration; encourage opportunities for discussion and exchange of
  Good Practices and produce reports with improvement proposals, as well as consult
  about their implementation.





### **METHODOLOGY**

Consultation to experts in Laws, Justice System and in the juridical process at a national and international level.

Organization of seminars and work groups to evaluate the actual process and compare it with the perception of the children and youth that participate in it, bearing in mind their necessities.

Elaboration of framework papers with the conclusions of the seminars and work groups and its diffusion and follow-up.



### **TARGET GROUP**

Professionals of the justice field, academics and politicians.



### **DURATION**

Since 2008.



### **RELEVANT EVENTS**

**Since 2008:** Participation in the National Commission for help to victims of violent crimes and Crimes Against Sexual Indemnity of the Ministry of Justice.

2011: the Federation had the opportunity to participate in the different spaces of participation for the elaboration of the Preliminary Plan of Reform of the Legislation relative to Children promoted by the General Board of Social Policy, Families and Children of the Department of Health, Social Policy and Equality and in the Seminars about the said Draft co-organized by the Platform of Child Organizations and the Chair for Law and Minors of the Pontifica Comillas University of Madrid. On the other hand, the Federation can also transfer its proposals to the Special Senate Committee on National Adoption and other related topics and was invited to participate in the annual meeting organized by UNICEF, the University Institute of Rights of Children and Adolescents (IUNDIA) and the General Judicial Council under the title "The Universalization of Child Rights against the insecurity of rights".

## SP2: PROGRAM FOR THE PREVENTION OF SEXUAL VIOLENCE AGAINST CHILDREN AND ADOLESCENTS

### **SUMMARY**

According to the Document of Presentation of the Council of Europe's Campaign "One In Five", available data suggest that around 1 out of 5 children in Europe might be victim of some form of sexual violence. It is estimated that in 70 to 85% of cases, the perpetrator is known by the victim. Child sexual violence can take many forms: incest and sexual abuse, pornography, prostitution, trafficking, corruption and sexual assault by peers. Children victims of sexual violence suffer more than just an intolerable violation of their physical integrity: their mental health can also be affected and their bonds of trust with adults destroyed. The victims often take refuge in silence because they feel shame, guilt and fear. Some child victims are so young that they have no idea what is happening to them, and very often children do not know how or where to seek help.

At the same time, commercial sexual exploitation of Children and Adolescents in all its types is a hard reality and Spain is not foreign to this reality that must be consider as a modality of child mistreatment.

Departing from this framework, FAPMI is conscious that this reality demands an effective response, with prevention being the best strategy.



### **MAIN OBJECTIVES**

To create awareness to the general population about the close reality of sexual abuse and sexual exploitation of boys, girls and teenagers.

To disseminate scientific and confirmed information about sexual violence against children and adolescents and effective prevention strategies.

Diffusion of information regarding detection, notification and available devices for attention to the victims.



### METHODOLOGY

Diffusion of information regarding data, definition, detection, notification and attention to cases of sexual violence against children and adolescents.

### **TARGET GROUP**

General population and professionals.



### **DURATION**

Since 1999.

FAPMI forms part of the Spanish Group of Work against Sexual Child Tourism, together with the General Secretary of Tourism and other organizations.

### **SUMMARY**

Taking into consideration that the most effective strategy for the prevention of child mistreatment is the promotion of the good treatment and the construction of a positive context around children and adolescents that allow their healthy growth (in a physical and psychological sense), the Federation implements this Program with the objective of raising awareness to support behavior changes focused specially on the families and the educative community.



### **OBJECTIVES**

To promote attitudes and behaviors that take in consideration the needs of children and adolescents.

To promote the use of positive discipline and the learning of alternative educational strategies and tools in the family and in school.

Train parents and educators in positive discipline methods, give them resources for the construction of a resilient context and offer scientific information about child development and needs.



## TP1: NATIONAL TRAINING PROGRAM IN PREVENTION AND INTERVENTION IN CHILD MISTREATMENT

### **SUMMARY**

In this Program, the Federation, with the collaboration and funding of the Ministry of Health and Social Policies, claims the training of professionals of different fields (education, health, social services, police, monitors of leisure...). The activities that form a part of the Program could be adapted to the necessities and characteristics of the participants (contents, extension, format, etc.). On the other hand, with the intention to give an effective response and continued support and advice, the training activities can be implemented in collaboration with the member Associations of the Federation.

### **MAIN OBJECTIVES**

To elaborate a complete training offer directed to professionals and future professionals in process of formation at different levels.

To give an effective response to the training necessities of the organizations and people that work with children and youth at risk and work in prevention and resilience.

To bring to those that work directly with children, youth and their families, the strategies, tools and knowledge validated experimentally and by means of research.



### **METHODOLOGY**

The main activities of this Program are:

- Organization of the Biannual Congress of Childhood Maltreatment.
- Management of the National Training Program.
- Elaboration of handbooks and didactic materials.

### TP2: "MY WELL-BEING IS YOUR RESPONSIBILITY"



### **SUMMARY**

Under the name "My wellbeing is your responsibility", the Federation of Associations for the Prevention of Child Mistreatment has been developing diverse acts of awareness and prevention of mistreatment to children and adolescents, directed to the general population since 2006. The main activity of this Program is the Annual Campaign for the Prevention of Child Mistreatment in collaboration with the Ministry of Health and Social Policy.

The Program includes the creation of an intransigent public opinion with the use of violence against children and adolescents and inadequate educational methods and, in the same sense, the diffusion of the Federation's public positioning by means of press release or presence in the Mass Media. One of the historical objectives of FAPMI has been the public denunciation of situations that violate Child Rights, especially related with mistreatment of children and adolescents. In 2010, this objective was emphasized, since the Federation considered the positioning opposite these types of situations as awareness activities of the entire population. ### **MAIN OBJECTIVES**

To increase the awareness of the general population and professionals regarding children and adolescents mistreatment.

To bring scientific information to the general population on child mistreatment and its prevention.

Support and diffusion of Campaigns of others.



### **METHODOLOGY**

Promotion of awareness activities directed to the citizens and professionals, including the



promotion and organization of expositions about child mistreatment.

Diffusion of information and messages through the Mass Media and Social Networks.

Organization of seminars and conferences about the reality of child mistreatment to the general population or specific sectors.



### **TARGET GROUP**

General population and professionals.



### **DURATION**

Since 2008.



### **RELEVANT EVENTS**

Organization and management of the II (2008), III (2009), IV (2010), V (2011) and VI (2012) National Campaign for the Prevention of Child Mistreatment in collaboration with the Ministry of Health and Social Policy.

- Il Campaign (2008): directed to the prevention of physical punishment. This Campaign was complemented with the celebration of the XX Anniversary of the Convention of Child Rights.
- Ill Campaign (2009): directed to the sensitization of the general population on the reality
  of child mistreatment and the increase of the notifications of cases of child
  mistreatment by citizens and professionals.
- IV Campaign (2010): directed to the diffusion of proposals for the improvement of the protection of children and adolescents in Spain.
- V Campaign (2011): Directed to the prevention, detection and notification of Sexual Abuse.

**2006:** Promotion of the exhibition "The fingerprints of mistreatment", a collection of drawings of children and adolescents victims of mistreatment and sexual abuse.

**2010:** Organization and promotion of the exhibition "Artists without intention", a sample of drawings and therapeutic materials of children and adolescents victims of mistreatment and



sexual abuse. This exhibition turns out to be different in regard to the previous one because it is focused on the therapeutic process and shows the evolution of some cases in different phases of the intervention. As a consequence, this one adds to the awareness goal, and a didactic use.

**2011:** Advising in the the exposition "Si Quebró el Cántaro (If the pitcher broke): abuse and mistreatment during childhood", organized by the Tenerife Space of the Arts (TEA), with an estimated 25,000 visits from June 22nd, 2010 to January 31st, 2011.

**2011/2012:** FAPMI coordinates in Spain the campaign of The Council of Europe "One In Five", to stop sexual violence against children. The campaign includes Multidisciplinary Professionals Training Courses on Prevention of Sexual Violence against children ages 3-7.

**2012:** During this year, our efforts will be focused on the diffusion and implementation of the Campaign "One In Five" in the Educational System.

### TP3: PROGRAM OF INFORMATION AND KNOWLEDGE MANAGEMENT

### **SUMMARY**

In our society changes are produced quickly and the advances in research provide data that permits more productive and effective interventions, which is why it is essential to have constant daily knowledge updates. In updating, one of the most developed, accessible and valued resources is written and audiovisual information that is at the disposition of professionals and the general population. With the opening and use of the FAPMI's Virtual Documentary Center in 2012, FAPMI wants to cover this need and to set up a source of information and training relevant to the associated people and entities, as well as to all of those interested in this phenomenon.

Within this line of action, FAPMI established a collaboration agreement with the Center of Documentation of Wellbeing and Child and Adolescent Mistreatment of the Faculty of Psychology at the University of Salamanca, under the direction of Professor Félix López Sánchez, a project developed with the help of the Junta de Castilla and León (Regional Government). With this agreement, FAPMI will take charge of the management of the Documentation Center.

Together with the publications carried out by the Federation, each one of the Member Associations develops other materials and contents that are edited in collaboration with the institutions and local and autonomous entities.

This Program is directly associated to the Service of Orientation and Information to Citizens (which is described hereinafter). The Program of Information and Knowledge Management includes the search, indexation and diffusion of all the contents regarding child protection and well-being that are available or which we have news. Part of these contents are specific for professionals or researchers but another part of them can be used to inform the general population when they need counseling about child mistreatment situations.

### **OBJECTIVES**

Elaboration, edition and publication of specific contents regarding prevention, detection, notification, attention and intervention in child mistreatment.



Search, indexation and diffusion of contents regarding child protection and well-being.



### **METHODOLOGY**

The main activities of this Program are:

- Elaboration and diffusion of several materials (reports, programs...) edited in paper or digitals in the different collections:
  - i. Collection "Publication for the protection of children and adolescents".
  - ii. Collection "Notebooks of well-being and child protection".
  - iii. Review "Well-being and Child Protection".
- Search, indexation and diffusion of materials, programs, researches, reports, articles and every type of information elaborated by others.
- Management of the Virtual Documentary Center about child protection and well-being in collaboration with the University of Salamanca.

### **SUMMARY**

Participation in the process of elaboration, follow-up and evaluation of regional and national policies and Plans. Given our experience and knowledge in the fields of child protection and attention to cases of child and adolescent mistreatment, the Federation tries to bring this experience and knowledge to the decision-makers and people and structures with power to improve the attention to children, adolescents and families at different levels.

The Program includes the promotion and support to the national, regional and local development of child policies, focused on the promotion of the child well-being and protection and the influence in the public opinion.

### **OBJECTIVES**

To bring scientific information and validated conclusions to the decision-makers with the goal of guaranteeing the bests conditions for the development of children and adolescents.

To promote the building of policies based on scientific evidence and the results of the work of the professionals directly involved in the attention to children and adolescents that are victims of mistreatment or, on the other hand, in the experience of professionals whom are obtaining good results in the fields of protection and prevention.
